We have applied for a Department of Historic Preservation and Architecture Grant to assist in the renovation of the Jail's built-in box gutters. It is a 50% matching grant and the total is \$21,500 with our organization needing to match their funding of \$10,750 with \$10,750 from our funds. We should know by February if we will receive funding. In any event, the gutter issue needs to be addressed and any suggestions and efforts you might give, would be greatly appreciated. All donations are fully tax deductible.

KENNEDY LIVING CENTER UPDATE

It is our understanding that CSC has an arrangement with the CARS organization which involves leasing the older hotel portion to them in two years. The City has placed an indefinite stay on any demolition of the older section. Our concern is its deterioration within the next two years prior to CARS taking possession. We have also volunteered to process the paperwork for putting it on the National Register with no cost to the CSC but have turned down our offer.

HISTORIC PRESERVATION COMMISSION

The board briefly discussed the potential for a Historic Preservation Commission (HPC) for the City of Martinsville. Even though a majority of the town is on the National Register, this does not prevent a building from being torn down. An HPC would act similarly to the Zoning Commission or Planning Commission with published meetings held each month. The mission of an HPC is to establish Historic Districts. The districts that the board discussed were Conservation Districts. Once a Conservation District is established, then prior to demolishing a building, moving a building or constructing a building, it must be approved by the HPC. In most cases, 70% of the building owners involved in a potential district must approve the district. A Conservation District could consist of one building, one side of the street, both sides of the street, a block, two blocks, etc. You might ask, "What positive effect would a Conservation District have on me?" In a business area, no one could tear down a building unless approved by the HPC. In addition, any new buildings would have to be approved by the HPC prior to being built. In a residential area, unfortunately some things happen to homes through "Acts of God" (i.e., storms, fires, etc.). If you live next to a house that is destroyed, would you want to see a home built that does not fit into your neighborhood and as a result could potentially decrease the value of your property? Major additions to existing homes would also have to be approved if these homes or buildings were in a Conservation District.

If you have any interest in becoming a member of a potential Historic Preservation Commission, please contact a board member and let us know of your interest. The only criteria for being a member of the Commission would be that you live within the City Limits and that you have a positive interest in preservation. The board is considering approaching the City Council to recommend that Martinsville create one of these Commissions. We would greatly appreciate your input.
